### **Indian Society of Criminology, Madurai Branch**

The Madurai branch of the Indian Society of Criminology was launched on January 30, 2003, with the assent of the Head office, Chennai. It functions from the campus of the Madurai Institute of Social Sciences, Madurai, inaugurated by the then **Hon'ble Justice T.V.Masilamani** of Madras High Court. ### **THEME OF THE SEMINAR *Role of Forensic Experts in Crime Investigation***

Law, Science and Technology have great relevance in our lives. When technology intrudes in the ambit of legal rights, it is checked by law. It cannot be denied that the law seeks the help of forensic science to protect legal rights and strengthen the evidence. Criminal Investigation is an applied science that involves the study of facts used to identify, locate and prove the guilt of a criminal. The investigation includes

all the proceedings under the Code of Criminal Procedure for the collection of evidence conducted by a police officer. A complete criminal investigation can include searching, interviews, interrogations, evidence collection and preservation and various methods of investigation. Nowadays, criminal investigations commonly employ modern scientific techniques known collectively as forensic science.

In recent years, Forensic Science has expanded to applying science to matters of law. Forensic science is an integrative subject combining several branches. It is used for inquiring about crime scenes and collecting evidence to be used in the trial to prosecute offenders in a court of law. It involves the application of scientific principles and methods to the evaluation of evidence. The law recognises the importance of forensic evidence in prosecuting criminal cases. The evidence found at the crime scene or otherwise is brought into laboratories and analysed using different technologies and methods. Development of new tools of investigation has led to the emergence of scientific tools of interrogation like:

- Narcoanalysis Test
- Brain Mapping Test
- Polygraphy Test
- DNA Profiling
- Fingerprinting Test

Forensic science is predominantly concerned with helping to establish the *actus reus* of a crime rather than the *mens rea* of the alleged perpetrator. When scientific methods are rigorously used, without prejudice, they can provide cogent evidence in uncovering and proving the crime. It involves collecting, preserving, and analysing evidence suitable for prosecuting an offender in a court of law. Increasingly, forensic experts collaborate with the investigation team in certain crimes and analyse evidence to determine what happened at the crime scene and identify real suspects. Thus, the application of forensic science in the criminal justice system is, therefore, an apparent need.
